



How to get printed IRS Tax forms for tax year 2018 for taxes to be filed by Tuesday April 15, 2019

Due to federal budget cuts for the Internal Revenue Service, there are fewer tax forms already printed and available for pickup in public libraries.

Timberland libraries will have **limited quantities** of the most commonly used pre-printed IRS Tax return forms – Form 1040

Timberland libraries will also have **limited quantities of pre-printed instruction books** this year.

All forms and instructions are available to print on demand from the [IRS website at IRS Tax Forms.](#)

Free online filing forms and instructions are also available online at IRS [FreeFile.](#)

If you're in a Timberland library, you can print forms and instructions yourself. The first 100 pages printed per week are free—after that the cost is \$0.10 per page. (Note - each side printed counts as a page.)

Since the tax instruction books are large, your best option is to find and read the instructions online or request a pre-printed instruction book mailed directly to you from the IRS through their toll-free number 800-829-3676, or online www.irs.gov/orderforms. If you need assistance finding or printing the forms, library staff can help you.

Library staff cannot provide assistance filling out the forms; however, many of our Timberland branches do have volunteers from AARP scheduled on specific dates who can provide assistance filling out tax forms. Use the "click here" link at the top of this page to get to the schedule for all the branches.

Whichever approach you choose, take care of it early, and avoid the crunch. Deadline dates related to United States income tax can be found at [Income Tax Deadlines.](#)
